This Cookies Notice is an integral part of the Data Privacy Policy for the KS Group of companies, which comprises KS Ventures AG, KS Ventures Invest AG, and KS-TF AG (hereinafter collectively referred to as the "**KS Group**" or "**we**"). In this notice, we provide you with information about how we use cookies and similar tracking technologies on our website and how you can manage your preferences.

What are cookies?

Cookies are small text files that are placed on your device (computer, tablet, smartphone) when you visit a website. They are widely used to make websites function more efficiently and to provide information to website owners. Cookies can be temporary (session cookies) or permanent (persistent cookies).

How do we use cookies?

We use cookies for various purposes, including but not limited to: website functionality (some cookies are essential for the proper functioning of our website. They enable you to navigate the site and use its features); Analytics (we use cookies to collect information about how visitors interact with our website. This helps us improve the site's performance and user experience).
